Notes / Highlights:

Our new communications site is operational: We have a few final pieces to complete however the system is up and operating.

Bear trap canyon fuels reduction project continues to be improved. We have not had an opportunity to begin firing. However, we anticipate new opportunities to fire when weather conditions allow. (Thank you to our personnel for their efforts on this project.)

We attended the annual IIMT (Interagency Incident Management Teams) meeting at the Riverside County Convention center. Various topics were discussed including but not limited to: Mutual Aid commitment and effort, Team membership participation, the new UAS (Unmanned Aircraft) Or (drone) programs and capabilities. Hand crew availability and depth. CIM (Complex Incident Management) vs. the continuance of Team "type" 1-4.

Due to snowfall accumulations, IFPD abatement inspections were pushed forward and we began inspections on May 15th. Our first round of inspections began on May 15th. We will continue the inspection process with second inspections estimated to take place in two weeks. We anticipate completion of the inspection process by June 30 2023.

IFPD CREW 621 has been entered into our available resource list. We have begun the task of preparing the USFS Thomas Mtn. Project. I attended the Mutual Aid forum in Ventura CA. Discussion regarding the CA Mutual Aid system took place among the Fire Chiefs throughout the State. New FC 42 Electronic version was rolled out by OES.

I also attended the IIMT South Ops annual meeting and the local AOP (Annual operating plan) Operational meeting.

IFPD is pleased to announce that Idyllwild Crew 621 is rostered in the IROC resource list: and, has already been utilized on an incident in Mecca Ca, IFPD hand Crew assisted the Riverside Co. Fire Department with the 66 wildfire incident on Monday May 15th.

The importance of Fuels Reduction projects and Private Ownership property abatement:

The Idyllwild Fire Protection District has been actively participating in the greater fuels reduction effort on the Mountain Plateau for decades. This vast network of fuels projects has proven to play a critical role in mitigating the threat of fire to the San Jacinto Mountain Communities.

Idyllwild has been evacuated 3 times over three decades:

In 1996 the "Bee Canyon" fire burned a total of 9,620 acres which caused the evacuation of Idyllwild and Pine Cove. No loss of life or property as a direct cause of the Bee Canyon Fire. During this incident the fire tested the newly completed "Strawberry" fuel reduction project. Fire crews were able to utilize this reduction area in their overall effort to keep fire from entering the residential communities.

In 2013, the "Mountain Fire" burned a total of 27,531 acres which caused the evacuation of Idyllwild and Pine Cove. No injuries nor loss of life was reported as a direct cause of the Mountain Fire, however, unfortunately 23 structures in the community of Mountain Center were damaged and/or destroyed.

In 2018, the "Cranston Fire" burned a total of 13,139 acres which caused the evacuation of Idyllwild and Pine Cove. No injuries nor loss of life resulted from this incident, however, unfortunately 3 homes were destroyed and a dozen others were damaged in the community of Idyllwild during this event.

Overall, these fires have demonstrated that planning, fuels reductions, property abatement and a robust Mutual Aid system all come together to deliver a successful outcome when fire is introduced to the landscape. Through the cooperative efforts of our MAST partners The San Bernardino National Forest and "San Jacinto Mountain Plateau" have a successful record of mitigating the threat of fire to its property owners, citizens and visitors.

Thank you to all of our citizens, and emergency cooperators for helping to make Idyllwild Fire Safe!

History:

My wife Karen and I have been Idyllwild residents for over 8 years. During our residency here in Idyllwild, I have spent much of my time Volunteering and woodworking in my shop. I was previously an IFPD Fire Commissioner from 2017 – 2022. In November of 2022 I was 1 of the four (4) candidates which ran for election to the IFPD Board. During the recent election I received 525 votes from the citizens of Idyllwild nearly 22% of the 2411 votes cast in the 2022 election with 4 candidates running for 3 positions.

I have worked as a Volunteer Firefighter with the Riverside County Fire Department

Prior to my relocation to the community of Idyllwild I spent nearly 30 years working in Law Enforcement employed with the Riverside County Sheriff's office. During my time in Law enforcement I was tasked with providing such services as: Emergency response, Administration, Public Information, Logistical Support, and other items required of the greater law enforcement service community.

My desire to continue our work as an IFPD Fire Commissioner is to ensure that residents like me and my family continue to receive professional, effective, efficient, and locally managed Fire and EMS Services.

I am an advocate of local Jurisdictions electing their own governing bodies and setting the levels of service that they (we) collectively feel are needed and required. It has been my observation that other "one size fits all" Fire and EMS agencies cannot, will not and do not have the desire nor capacity to mold their service models into the best fit for the residents of a given community.

Meeting held both physically at 54160 Maranatha Dr. Idyllwild CA. and by video/electronic means.

Call to Order: 15:00

Roll call: Commissioners: President Messina; Vice President Fogle; Secretary Andrewson; Commissioner Reitz; Commissioner Yost; Chief Mark LaMont, Detailed Battalion Chief James LaMont and Executive Assistant Rachel Teegarden

Pledge of Allegiance: President Messina

Invocation: Commissioner Fogle

Citizens' Comments: - Jon Engel spoke about when he came in and helped out with the wind event and how well the crew worked together. He was proud to work beside the staff during that challenging wind event.

Reports

- President Messina – *Would like to thank Chief LaMont for stepping up and helping out Big Bear with their snow event. We would like to hear from Chief LaMont on what he learned up there.*
- Vice President Fogle – *Nothing to report at this time.*
- Secretary Andrewson – *Would also like to thank the Chief for serving Big Bear in their time of need. Had the opportunity to attend the FDAK conference and the pluthery of information that was given. Will have a report on the information that was presented.*
- Commissioner Reitz – *Honored and touched by the community for electing me as a fire commissioner but with saddness and joy I am going to resign effective immediately as commissioner. I will be moving to be with my husband at the end of April. Commissioner Andrewson thanked Commissioner Reitz. Chief LaMont asked for Commissioner Fogle to pray for Christina Reitz as she begins this next chapter in her life, Chief LaMont added; “ We wish Commissioner Reitz well and thank her for her service”.*
- Commissioner Yost – *Would like to thank the Fire Department for all the help that they gave to the Community Center with the cutting and removal of fallen trees across the creek. They didn't have the resources to pay for a company to come in and remove these trees. Chief LaMont stepped in with a training opportunity for our new reserves that needed some chainsaw training and completed the work.*
- Chief Mark LaMont. – *(Please also see Chief LaMont's written report). In addition to the written report Chief LaMont wanted to thank Fern Valley Water District - GM Victor Jimenez. Every project the IFPD is working on Victor has stepped up and helped start or complete a project. He helped clear the road to the Comm Site that was covered in snow, and assisted us in getting the connex container and generator up there. As Commissioner Yost said there is still work to be done on the ICC property Victor has offered to bring his tractor in to help get some of the bigger logs off of the ICC property. Victor has also brought to our attention of some large rocks that have fallen in the road on Chipmunk, we will be working this next week to insure access can be made. Chief LaMont asked IFPD legal council Steven Graham to speak about the vacancy in the Board. (SG) “The District will need to post the public notice for 15 days and the Board will need to appoint a new Board Commissioner within 60 days or the board of supervisors will appoint one”. Chief LaMont brought up the Leih family for his official swearing in ceremony. Congratulations to FFEMT Josh Leih for passing probation, the “IFPD is blessed to have him on staff”.*

Thank you for answering the call to serve this community. Chief LaMont would like take a minute to thank the entire Idyllwild Fire Department, all the volunteers, all the career staff, the admin staff that jumped in at a moments notice during the weather/snow event(s). The snow event was an incredible educational opportunity for those of us that work in this business. Running Springs received 90 inches of snow (their average snow fall is 38 inches and historic high level snow fall is 47 inches) Would love to have the opportunity to talk about what was learned in the AAR (after action review). Idyllwild Fire had 11 staff serving in San Bernardino on the Snow incident. The State's mutual aid and unified system worked great and operated just like it was created for. They had 1300 miles of roadway that needed to be cleared. The gas company graciously helped out in removing the berms that were created at the foot of the driveways from clearing the roads. Would also like to thank Rachel, Rob and Johnathan for all the hard work that was put into getting the audit completed. Thank you to the Board for supporting and offering the oppurtunity to serve in the Mutual Aid effort.

- *BC J. LaMont reported on the communication site; The generator is in place, working on the final components for the solar system; the electricition was up there today getting some of the items hooked up. The LE100 abatement program will begin mid May (May 15) this year, (depending on weather constraints) We have teamed up with Team Rubicon this year. With the help of a fire prevention grant, Team Rubicon will be able to assist the IFPD and property owners with some of the abatement deliquent properties throughout the community. As I finish my BC detail I wanted to take this oppurtunity to thank the Board and the Fire Chief for this incredible experience. I was able to take on the Comm Site project and get that just about completed. Building relationships with Buckhorn Camp and Camp Emerson to get the Bear Trap Canyon project up and running. Station improvements on the Dorm Rooms to make those more livable for our guys, still working on the Captains and BC office. Had the oppurtunity to attend and get inbeded with the MAST and Guns and Hoses groups. Learned about payroll and the Mutual Aid reimbursement program. Working with Hemet on their training facility and partnering with them to train with them. All of these oppurtunities that I have been given have been a great educational oppurtunity for me.*
- *Idyllwild Volunteer Fire Company (Riggi) – We are working to expand our group and those interested in becoming a volunteer can contact us. Steve and myself will be attending the California State firefighters Conference in April*

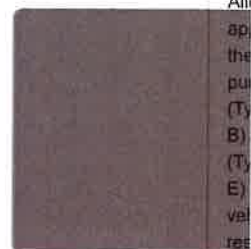
