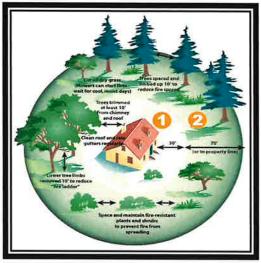

- Halloween event downtown, passed out Fire Prevention information (And Candy!)

# 2023 Property Abatement Results:

The Idyllwild Fire Protection District inspects 3829 properties each year.



- As Per IFPD Ord. 19-01 we have begun performing our annual abatement inspections on ALL properties within IFPD jurisdiction. IFPD crews completed the first round of inspections on **April 30th** and failed inspection notices were mailed out to 623 property owners (Last year we mailed out over 705 fails on the first round of inspections.
- ➤ Second inspections will begin May 15<sup>th</sup>, After the second inspection notices are mailed out, then a three week interval is given to complete the work prior to the final inspections being performed.
- ➤ We anticipate final inspections in June. Last year **81** citations were mailed out on those properties which remained out of compliance.
- > Overall 2023 abatement results: **97% compliance** and

**3% noncompliance**. We continue to work with those who have not come into compliance to ensure all have met / will meet the minimum abatement requirements.

# Ongoing Property Abatement 2024:

As with previous years the Idyllwild Fire Protection
District will continue inspecting ALL (3829) properties
for compliance with ORD 19-01. This local ordinance is
in addition to the CA State abatement regulations: (IFPD
abatement Inspections begin late spring generally Mid
to Late April – Early May each year). This year's 1<sup>st</sup>
inspections have been conducted with 623 1<sup>st</sup>
inspection fail notices being mailed out. IFPD has reinspected the 623 parcels with final fail notices being
mailed out to 248 property owners. Citation notices



have been mailed out to any property owner not found in compliance.

Items which top the "Failed" inspection list each year are:

- Address Numbers These must be 4" or greater in size and must be visible from the street in a contrasting color.
- Clearance around Propane Tanks Must have a minimum of 10' clearance around LP tanks.
- Roof clear of flammable debris Your roof must be free from pine needles, leaves, and other flammable debris.
- Thirty (30') ft. clearance of all vegetation around your home.

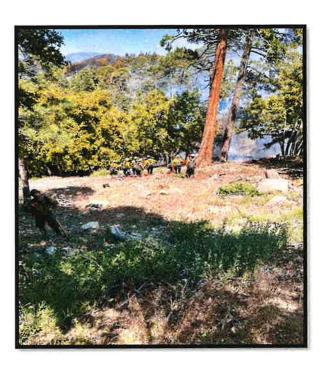
Please check our website or contact our office with any questions you may have regarding Property Abatement, the IFPD will be happy to assist you! Property Abatement is an ongoing responsibility.

Ongoing Fuels Projects: The Idyllwild Fire Protection District continues to work with our Cooperative Partners on fuels reduction and community resiliency projects: Thomas Mountain, Westridge, South Ridge, Strawberry, and other local fuels projects. The IFPD has also had the opportunity to assist with fuels projects in the Cleveland National Forest.

<u>Update: (Partnership agreement with the USFS is completed)</u>

# **Bear Trap Fuel Reductions:**

IFPD continues working on this critical fuel reduction project with the private property owners to reduce fuels on a ridgeline west of Idyllwild and east of Bear Trap Canyon. These fuels reductions will greatly strengthen our fire prevention efforts along with the other ongoing fuels reductions projects on west ridge, south ridge, and strawberry fuel reductions. We anticipate an RX treatment in early 2024 on this project.



Update: The Bear Trap fuel project is ready for an RX (firing) treatment. We will likely need to do a "re-entry" on this project early 2025 and then apply the Rx treatment.

# **Communications Site:**

The IFPD completed improvements to our communications site. The IFPD plans to relocate WNKI (1610 am emergency radio) to the site which will greatly enhance our overall emergency communications network and provide a larger coverage area for the community. This relocation is anticipated to take place early 2024. Thank you to all those who participated in making this project a huge success! (We are currently working with SCE on providing permanent power to this site) Currently we have LP generator power and solar energy providing power to the site.

<u>Update: We have worked through the project planning process with SCE and anticipate</u> having final "site plan" approvals soon, this will provide permanent power to the site.

### **Individual and ongoing Community CPR Classes:**

IFPD delivers several CPR classes each year. In 2023 we provided five (5) CPR classes for the USFS, two (2) local tree company classes, two (2) local camp



employees courses and two (2) community CPR classes. We have already provided six (6) CPR class in 2024, one for the local water districts one for MCFSC, one for Tree Companies, one for the local medical clinic, one for local camps and a



community "citizen" CPR class. (Persons interested in attending a CPR class should contact our office and speak with Rachel for details and schedule)

# CERT (Community Emergency Response Team)

IFPD held a full CERT Course in October of 2023. We also conducted 1 refresher course in June of 2023. IFPD sponsors MDP (Mountain Disaster Preparedness) and partners with them in the training of new CERT members. Twenty-two new CERT members took the October 2023 training course.



The IFPD anticipates putting on one (1) new CERT course and one (1) refresher course in 2024. Check our website or call our office for details regarding upcoming classes. Thanks to all who assisted and participated in these training classes.

#### IFPD CREW621:

Members of Crew 621 received an "in Service" training on May 19<sup>th</sup> 2024

Crew 621 has a greater than 80% return of last year's members which will allow crew 621 to reclassify as a type II IA crew (upgrading from last year's classification of Type II) All members have received a full in service "red card" training and the crew is in service and has already been assisting the USFS (BDF) San Jacinto Ranger District with the continued prescribed burn project at Thomas Mountain, and has also provided Mutual Aid to the Sierra National Forest from June 29<sup>th</sup> through July 12<sup>th</sup> 2024. Great Job CREW 621!!!



IFPD Crew 621 was instrumental on mitigating the fire threat to the Communities of Angelus Oaks, Big Bear, Arrowhead and Running Springs during the 2024 Line Fire Incident.

# Training:

All IFPD members continue to complete and exceed all minimum fire training requirements. 30 hours of minimum training per month for all career staff members and, 20 hours of continuous training for all reserve/intern and crew members. Annual EMS education (continuing education was completed in January and February of 2024 for all IFPD employees/admin staff and intern reserves). All IFPD suppression personnel have completed the annual "red card" training.

**IFPD** was extremely busy throughout the 2023/24FY, and continue to be busy in the early months of the 24/25 FY. In addition to our regular call volume and automatic - mutual aid services that we provide, the IFPD also:

- hosts several school visits and fieldtrip to the Fire Station, Participates in Fire Prevention Month by visiting the Idyllwild School and educating our Kids on Fire Safety, visiting the Idyllwild Library for "Storytime" reading with the Kids, Visiting Awana at the Idyllwild Bible Church for fire prevention week, we had a Great visit with Senator Kelly Seyarto to discuss fire safe communities. We consistently Participate in the annual Fourth of July Parade, the Idyllwild Halloween Parade and Carnival and the Annual Idyllwild Christmas Tree Lighting. We met with Congressman Ken Calvert and his staff, we have had the opportunity to speak with numerous local membership groups (Rotary, Idy Elders, Water Districts) IFPD assisted the USFS with their "C" FAL1 certification program, and also put on our own "C" Faller1 certification class this year.

#### Reports

- President Messina It has been a very busy summer for everybody and wanted to reiterate the importance of the Mutual Aid program. If we aren't there for other folks how can we ask for help when we need it. It is way more than just putting the wet stuff on the red stuff, it is helping citizens, helping ourselves and doing God's work.
- Vice President Sawicki Wanted to tag onto what President Messina talked about and living through the Cranston fire, almost losing his house really taught him the importance of the Mutual Aid program. Also wanted to mention that at Church a few weeks ago a few members came up to him and thanked him for the service they received from staff at a recent emergency call. He also wanted to thank the staff that was on a couple of days ago when his daughter needed our services. He was so proud of the staff, and especially proud to be apart of this Board and to serve this community. Wanted to update on the Ad Hoc committee reagarding the contract. Met with Chief LaMont along with Commissioner Andrewson and they have decided to hold off on anymore meetings until after the new year as the contract doesn't need to be looked at until 2025.
- Secretary Andrewson As a member of this community wanted to acknowledge the services that she personally received when she had her medical emergency. Wanted to thank everyone for their prayers while she and Don were going through their medical issues. Don is now in remission and she has started to feel normal after her mini stroke and major surgery.
- Commissioner Yost Nothing to report at this time.
- Commissioner Fogle Nothing to report at this time.
  - IVFC The volunteers have picked a date for the spaghetti dinner on November the 23<sup>rd</sup>. It will be at Camp Maranatha this year and they are currently working on raffle prizes and are selling tickets. The Volunteers are very excited to get this event back up and running. They have a few new recuites they are working with and trying to get them through orientation. The school BBQ's are back up and going once a month, they come along with the duty crew to cook and serve hamburgers to the kids for lunch. They used to be on Friday's and this year they are on the 2nd Wednesday of the month.
- Chief Mark LaMont. (Please also see Chief LaMont's written report).
  One of the most heart stopping moments of his career to have this 4 year old girl come up to him and ask him what he was working on and wanted to look at the map and it was a great reminder as to why he does what he does and the citizens that we do this for. Being reminded of his grandchildren, wanted them to have someone save their house just as he was doing it for this little girl. Abatement for 2024, the community didn't do as well as in recent years past. We really need the public's help as we can not do this alone. We need hlp to get rid of those flashy fuels, please keep up with your abatement. If people have qustions or need help

with abatement please come to the office and we can try and walk you through the different avenues of getting that accomplished. Thank you to Steve, Tonya and all of the Volunteers for their assistance in helping us get the community members that needed address signs taken care of. Chief LaMont also noted the Thomas Mountain burn along with the Bear Trap fuel project were cut short due to fire season and those will get back up and going next year. We will likely need to go do some clearing before we can start to burn next year to get rid of the re-growth. He has been asked why our partnership with the USFS is so important. The simple answer is the more green engines we can call on when we need them the better and if they have an incident over on Thomas and all the green engines are over there, how many will be able to come and assist us when we need them at the same time. In return for helping them with the Thomas Mtn. project, they will come out and help us with the Bear Trap fuels project. The communications site is up and running. SCE is working on permanent power, currently we have solar and battery back up but working with them to ensure we always have power at that site. Any commissioner who would like a tour of this site please let him know and he can accommondate that. We will be scheduling a CERT class, please get with Rachel if you would like to attend that. We have been on many Mutual Aid assignments this year. We have currently billed 2,870,000 so far this fiscal year. Team 11 will be taking over the Line fire (near Big Bear) this week. We did get approved for the CalFire grant in the amount of \$ 987,000.00 for a priority landscape / wildfire prevention fuels reduction grant. We will get to use that money for vehicles, tools, equipment, and labor as the grant prescribes. We will need to put in about \$ 120,000.00 for our portion. The grant covers maintiance on previous fuel break projects and also includes clearing of the thoroughfares and road systems throughout ldyllwild, such as the easments off highway 243 that run through town, any of the main arteries and road systems. We anticipate getting those monies after the first of the year in early 2025. We can not purchase anything until we get our letter stating that we can start making purchaces. This is the largest grant we (IFPD) have ever received. The previous largest grant was a few years ago when we received about 120,000 for SCBA bottles. Crew 621 has been out several times this fire season and we have received great feedback from incidents that they have been out on. They are representing the district extremly well. Commissioner Sawicki asked where we were with the 2nd emegency siren. Chief LaMont responded by stating that the County has been working on an emergency siren system for the last 5 years and that he has been waiting for a response from the County as to where they are at with that as we would like to save the IFPD and FVWD dollars if the County is going to put one up. Commissioner Andrewson asked if we could do a fundraiser to help with those dollars. Commissioner Yost suggested we do an informational "Town Hall" meeting to let people know what it's for and where the money is going to help kick off the fundraiser.

POLICY TITLE: Reserve Fund Policy

POLICY NUMBER: 3121

- 3121.1 This Policy is intended to provide direction concerning the District's reserve funds.
- 3121.2 The Idyllwild Fire Protection District reserve policy is a financial policy guided by accounting principles of public fund management. The policy establishes reserve funds to insure the continued and seamless delivery of emergency fire and ems service and the organized and orderly replacement of District Vehicles and Capital Equipment.
- **3121.3** The adequacy of the target reserve year-end balance ranges and/or annual contributions will be reviewed annually during the budgeting process and may be revised accordingly.

<u>Purpose</u>: To provide funds for the <u>continued and seamless delivery of emergency fire and ems service and the organized and orderly and timely replacement and expansion of District Vehicles and Capital Equipment to meet future demand and to provide for ongoing repair and maintenance of District property and to maintain and/or improve on the District's existing level of service.</u>

Target Balance: This Policy does not designate a target reserve balance.

Methodology/Rational: Fire and Medical Aid services which are responded to by the District require the use of District vehicles and equipment. As the equipment reaches the end of its projected life cycle or maintenance becomes too costly new vehicles and equipment will need to be purchased. Aging facilities will require ongoing maintenance, repairs, or replacement as required.

- **4020.1** Members of the Board of Commissioners shall attend all regular and special meetings of the Board and arrive to such meetings in a timely manner unless there is good cause for absence or late arrival.

  - **4020.1.2** The Fire Chief shall notify the Board during the roll call section of the scheduled Board meeting of any absence or potential late arrival of any Board members and any known reason for the any absence or potential late arrival of any Board members.
- **4020.2** A meeting of the Board of Commissioners may be conducted using teleconferencing as provided for in Government Code Section 54953(b). The requirements for a teleconferenced are as follows:
  - **4020.2.1** Teleconferencing may be used for all purposes during any meeting;
  - **4020.2.2** At least a quorum of the legislative body must participate from locations within the District's Boundaries;
  - **4020.2.3** Each teleconference location must be specifically identified in the notice and agenda of the meeting, including a full address and room number, as may be applicable;
  - 4020.2.4 Additional teleconference locations may be made available for the public;
  - **4020.2.5** Agendas must be posted at each teleconference location, even if a hotel room or a residence.
  - **4020.2.6** Each teleconference location must be accessible to the public and have technology, such as a speakerphone, to enable the public to participate;
  - **4020.2.7** The agenda must provide the opportunity for the public to address the legislative body directly at each teleconference location;
  - 4020.2.8 All votes must be by roll call.
- **4020.3** Notwithstanding the requirements of Section 4020.2 above, during a proclaimed state of emergency when meeting in person would present imminent risks to the health or safety of attendees, a meeting of the Board of Commissioners may be conducted using teleconferencing without the requirements of Sections 4020.2.1 4020.2.8 above so long as all of the following occur:
- **4020.3.1** Notice of Access and Comment Options. Whenever a teleconferenced meeting notice or agenda is posted, it must include details on how the public can access the meeting and participate in public comment. The agenda should provide options for attendance via phone or internet.
- **4020.3.2** Disruption of Meeting Access. If there is a disruption that stops the meeting broadcast or prevents public comment through the call-in or internet options, the Board must pause any decisions on agenda items until public access is restored.
- **4020.3.3** Real-Time Public Comment. The Board cannot require public comments to be submitted before the meeting. The public must be allowed to comment in real time.

- **4020.3.4** Registration Requirements for Online Comment. If a third-party platform (not controlled by the Board) requires registration to join the teleconference, members of the public may need to complete that registration to participate.
- **4020.3.5** Timing for Public Comment Periods. If the Board sets a specific time for public comment on each agenda item, it must allow the full time to pass before closing public comments. If comments are taken separately on each agenda item without a set time limit, the Board must allow reasonable time for the public to provide comments. If there is a general public comment period with no specific agenda item, the Board must keep the comment period open for the full allotted time.
- **4020.3.6** The Board shall revisit the need to hold teleconferencing during the proclaimed state of emergency at least every 45 days to determine if teleconferencing remains necessary.
- **4020.4** Notwithstanding the requirements of Section 4020.2 above, the Board of Commissioners may use teleconferencing for one of their members due to "just cause" (not more than twice a year) or request permission due to "emergency circumstances."
  - **4020.4.1** The Member must discloses if other adults are present with them at their remote location.
  - **4020.4.2** The Member must participate via both audio and video.
- **4020.4.3** A quorum of Members must be present at the published in-person location within the District for the meeting.
- **4020.4.4** The meeting notice and agenda must include details on how the public can access and comment remotely (e.g., call-in and internet options). The agenda must list options for the public to join via call-in, internet, or in person.
- **4020.4.5** Disruption of Meeting Access. If there is a disruption that stops the meeting broadcast or prevents public comment through the call-in or internet options, the Board must pause any decisions on agenda items until public access is restored.
- **4020.4.6** Real-Time Public Comment. The Board cannot require public comments to be submitted before the meeting. The public must be allowed to comment in real time.
- **4020.4.7** Registration Requirements for Online Comment. If a third-party platform (not controlled by the Board) requires registration to join the teleconference, members of the public may need to complete that registration to participate.
- **4020.4.8** No Member may participate remotely for more than three consecutive months, 20% of regular meetings per year, or more than two meetings if the Board meets less than 10 times annually.
- **4020.4.9** "Emergency circumstances" means a physical or family medical emergency that prevents a member from attending in person.
  - **4020.4.10** "Just cause" means any of the following:
    - (A) A childcare or caregiving need of a child, parent, grandparent, grandchild, sibling, spouse, or domestic partner that requires them to participate remotely.
    - (B) A contagious illness that prevents a Member from attending in person.
    - (C) A need related to a physical or mental disability not otherwise accommodated.
    - (D) Travel while on official business of the District or another state or local agency.

- 4025.3 Implementation. Whenever District employees or commissioners desire to be reimbursed for outof-pocket expenses for item(s) or service(s) appropriately relating to District business, they shall submit
  their requests on a reimbursement form approved by the Fire Chief. Included on the reimbursement form
  will be an explanation of the District-related purpose for the expenditure(s), and receipts evidencing each
  expense shall be attached.
  - **4025.3.1** The Fire Chief shall review and approve all reimbursement requests other than reimbursements for the Fire Chief. Reimbursement requests by the Fire Chief will be reviewed and approved by the Board President or the President's designee.
  - **4025.3.2** All expenses must be reasonable and necessary, and employees and commissioners shall exercise prudence in all expenditures.
  - 4025.3.3 The most economical mode and class of transportation reasonably consistent with scheduling requirements shall be used. In the event a more expensive class of transportation is used, the reimbursable amount will be limited to the cost of the most economical class of transportation available. Reimbursement for use of personal vehicles will be at the applicable IRS-approved rate.
  - 4025.3.4 Expenditures for food and lodging will be moderate and reasonable. Reimbursement for food shall not exceed \$20.00 for Breakfast, \$20.00 for Lunch, or \$25.00 for Dinner. Reimbursement against receipts will not exceed \$65.00 per day plus tax and reasonable tip. There will be no reimbursement for alcohol. Reimbursement for lodging will be capped at CONUS rates for the geographical location in which the lodging takes place.
  - 4025.3.5 The use of a rental vehicle must be pre-approved by the Fire Chief.

4025.3.6 For Commissioners, if the lodging is in connection with a conference or organized educational activity, lodging costs shall not exceed the maximum group rate published by the conference or activity sponsor, provided that lodging at the group rate is available to the member of a legislative body at the time of booking. If the group rate is not available, the member of a legislative body shall use comparable lodging that is either available at a government rate but in no case shall exceed the CONUS rates for the geographical location in which the lodging takes place. A Commissioner may choose to incur additional costs above the reimbursement rate established by this policy, but does so at their own expense.

POLICY NUMBER: 4097

4097.1 The Commissioners for the District Board of Commissioners dyllwild Fire Protection District are elected in accordance with the Principal Act of the District Fire Protection District Law of 1987. From time to time a vacancy may occur on the Board for a variety of reasons. This policy is established to provide general guidelines and procedures for filling a vacancy on the Board consistent with the requirements of Health and Safety Code Section 13852 and Government Code Section 1780. Under state law, the District has a total of sixty (60) days in which to take action.

- 4097.2 The Board of Commissioners shall be informed immediately of the vacancy resignation or death of a member of the Board of Commissioners. The Board of Commissioners shall consider whether to act to fill the vacancy, either by appointment or by calling a special election.
- 4097.3 The District shall notify the county elections official of the vacancy no later than fifteen (15) days after the District Board is notified of the vacancy or the effective date of the vacancy, whichever is later.
- 4097.4 In cases where the Board determines to appoint a replacement to the Board, the District may publish a public notice of a vacancy and the process for considering candidates in a local newspaper of general circulation. The Board may establish an application and interview process including requiring a resume or application form detailing qualifications and experience of the candidates.
  - 4097.4.1 The District shall post notice of vacancy (per California code and regulations) in at least three conspicuous places in the District at least fifteen (15) days before the Board makes an appointment. If the Board makes an appointment, the District shall notify the county elections official within fifteen (15) days of making the appointment.
- 4097.5 The Board may review and invite those candidates that a majority of the Board determines are the most qualified or all of the candidates for an interview before the Board at a public noticed meeting. The Board may then consider the interviewed candidates and vote to determine if a majority of the Board can agree on a selected replacement candidate.
- 4097.6 If the Board of Commissioners chooses to call an election, the Board must do so within sixty (60) days of notification of the vacancy or the effective date of the vacancy, whichever is later.
- 4097.7 All costs for any election shall be identified for consideration by the Board for the decision of appointment or election.
- 4097.8 If a vacancy occurs in the first half of a term of office and at least 130 days prior to the next general district election, the person appointed to fill the vacancy shall hold office until the next general district election that is scheduled 130 or more days after the date the district board is notified of the vacancy, and thereafter until the person who is elected at that election to fill the vacancy has been qualified. The person elected to fill the vacancy shall hold office for the unexpired balance of the term of office.
- 4097.9 If the vacancy occurs in the first half of a term of office, but less than 130 days prior to the next general district election, or if the vacancy occurs in the second half of a term of office, the person appointed to fill the vacancy shall fill the balance of the unexpired term of office.
- 4097.10 If the Board fails to take action in the sixty (60) day period, state law provides that the County Board of Supervisors may appoint a successor to fill the vacancy or call an election.

- 4097.4 In cases where the Board determines to appoint a replacement to the Board, the District may publish a public notice of a vacancy and the process for considering candidates in a local newspaper of general circulation. The Board may establish an application and interview process including requiring a resume or application form detailing qualifications and experience of the candidates.
  - **4097.4.1** The District shall post notice of vacancy in at least three conspicuous places in the District at least fifteen (15) days before the Board makes an appointment. If the Board makes an appointment, the District shall notify the county elections official within fifteen (15) days of making the appointment.
- 4097.5 The Board may review and invite those candidates that a majority of the Board determines are the most qualified or all of the candidates for an interview before the Board at a public noticed meeting. The Board may then consider the interviewed candidates and vote to determine if a majority of the Board can agree on a selected replacement candidate.
- **4097.6** If the Board of Commissioners chooses to call an election, the Board must do so within sixty (60) days of notification of the vacancy or the effective date of the vacancy, whichever is later.
- 4097.7 All costs for any election shall be identified for consideration by the Board for the decision of appointment or election.
- 4097.8 If a vacancy occurs in the first half of a term of office and at least 130 days prior to the next general district election, the person appointed to fill the vacancy shall hold office until the next general district election that is scheduled 130 or more days after the date the district board is notified of the vacancy, and thereafter until the person who is elected at that election to fill the vacancy has been qualified. The person elected to fill the vacancy shall hold office for the unexpired balance of the term of office.
- **4097.9** If the vacancy occurs in the first half of a term of office, but less than 130 days prior to the next general district election, or if the vacancy occurs in the second half of a term of office, the person appointed to fill the vacancy shall fill the balance of the unexpired term of office.
- **4097.10** If the Board fails to take action in the sixty (60) day period, state law provides that the County Board of Supervisors may appoint a successor to fill the vacancy or call an election.

**WHEREAS**, The Idyllwild Fire Protection District has determined that it would be in the best interest of the District to adopt the Local Hazard Mitigation Plan.

NOW, THEREFORE, BE IT RESOLVED THAT THE IDYLLWILD FIRE PROTECTION DISTRICT BOARD OF COMMISSIONERS HEREBY ADOPTS the Local Hazard Mitigation Plan to meet the requirements of the Disaster Mitigation and Cost Reduction Act of 2000 and directs the IFPD Fire Chief to forward the Local Hazard Mitigation Plan to the County of Riverside Emergency Management Department, California Governor's Office of Emergency Services and Federal Emergency Management Agency on behalf of the IDYLLWILD FIRE PROTECTION DISTRICT for final approval.

#### **EXECUTIVE SUMMARY**

The purpose of this local hazard mitigation plan is to identify the local hazards, review and assess past disaster occurrences, estimate the probability of future occurrences, and set goals to mitigate potential risks to reduce or eliminate long-term risk to people and property from natural and manmade hazards.

The plan was prepared pursuant to the recommendations/requirements of the Disaster Mitigation Act to achieve eligibility and potentially secure mitigation funding through Federal Emergency Management Agency (FEMA) Flood Mitigation Assistance, Pre-Disaster Mitigation, and Hazard Mitigation Grant Programs.

The efforts of the Emergency Response Providers throughout the County to maintain a disastermitigation strategy are on-going. Our goal is to develop and maintain an all-inclusive plan to include all jurisdictions, special districts, businesses, and community organizations to promote consistency, continuity, and unification.

The planning process followed a methodology presented by FEMA and CAL-EMA which included conducting meetings with the Operational Area Planning Committee (OAPC) coordinated by the Office of Emergency Management comprised of participating Federal, State, and local jurisdictions agencies, special districts, school districts, non-profit communities, universities, businesses, tribes and general public.

The plan identifies vulnerabilities, provides recommendations for prioritized mitigation actions, evaluates resources, identifies mitigation shortcomings, provides future mitigation planning and maintenance of existing plan.

The plan will be implemented upon FEMA approval.

#### SECTION 1.0 - COMMUNITY PROFILE

#### 1.1 IDYLLWILD MAP



#### 1.2 GEOGRAPHY AND CLIMATE DESCRIPTION

The Jurisdiction is a Special Fire District located in the unincorporated mountain community of Idyllwild, Riverside County. It is approximately 8 square miles in area located about 50 miles east of the county seat. The community of Idyllwild is surrounded on all sides by the San Bernardino National Forest and is transected from NE to SW by Strawberry Creek. Even though there is a creek running through the community, there is no land that, for disclosure purposes in escrow, would be considered within the "flood plain".

The "District" is in mountainous terrain from 4,500' to 7,500' elevation in a mixed conifer forest fuel type. The Clark section of the San Jacinto Fault runs NW to SE and is SW of the community approximately 7 miles at the closest point. The San Jacinto Fault is considered to be the most active fault in Southern California.

Idyllwild averages 26 inches of rain per year with a percentage (around 30%) of that falling as snow in three to five noteworthy storms per winter. Summer thunderstorms have also contributed to the total rainfall accumulations. In addition, the district is threatened by wildland fire as all of the District boundary resides within the (WUI) Wildland Urban Interface.

#### 1.3 HISTORY

The Idyllwild Fire Protection District was formed in 1946 to provide fire protection to the rural community of Idyllwild. IFPD Ambulance service evolved from its beginnings as a BLS first response service in 1947 to an ALS Paramedic response model which began in 1979 and continues to this day.

#### 1.5 ECONOMY DESCRIPTION

IFPD Jurisdiction is primarily a residential community. Development in the Community is approximately 90 percent residential, and 10 percent commercial, less than 1% percent light industrial. Forty-five percent of the residences are part time and Fifty-five percent are full time residents. The Jurisdiction is funded by a small percentage of property taxes (structural fire tax) and a unit fee per parcel within the fire protection district jurisdiction.

There are no chain restaurants or businesses owned by large corporations within the community so there is no "primary" employer in the community of Idyllwild. Weekend tourists support many of the shops, businesses and local restaurants. As a result, many of the residents work in the surrounding communities.

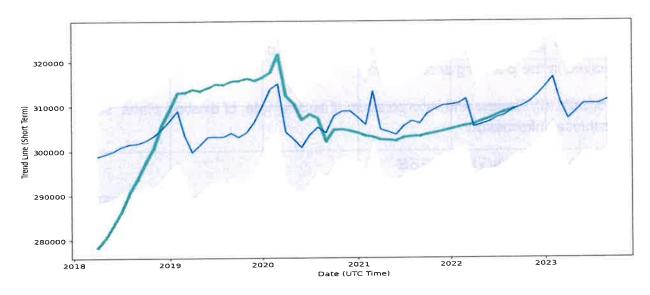

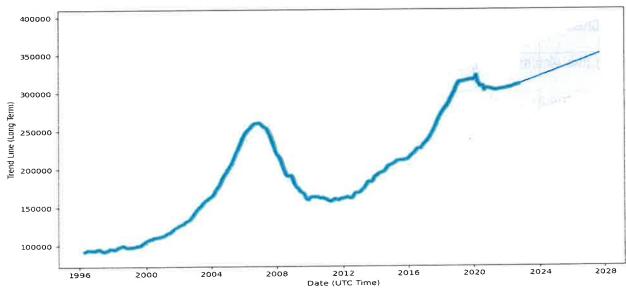
#### 1.6 DEVELOPMENT TRENDS / POPULATION AND HOUSING

The current population is estimated at 4,250. This represents an increase over the past population of 3200.

Due to the geographical features and jurisdictional boundaries of the Idyllwild Fire Protection District, which is surrounded by the San Bernardino National Forest, there is little area for large scale expansion of the residential and business districts. There are approximately 650 residential lots which remain available for new construction.

The Idyllwild Fire Protection District participates in a variety of State, County, and local planning meetings, workshops, conferences, automatic and mutual aid incidents including but not limited to MAST, MCFSC, County Fire Chiefs, Operations Section, Cal Fire Chiefs, County Board of Supervisors USDA/USFS, and the IFPD Board of Commissioners. IFPD Commission meetings are held every other month where public comment is heard.

The planning process involves a review of the following:

- Idyllwild Fire Protection District Ordinance(s)
- Potential and known hazards that impact the jurisdiction.
- Local Hazard Mitigation Plan and FEMA Recommendations.
- Historical data for prior hazards since approval of current plan.
- Mitigation strategies.
- Public comment from meetings.

#### 2.2 MITIGATION PLANNING PROCESS

Since Idyllwild Fire Protection District is a single entity (Special District) and is not combined with any other government function, the Fire Chief and Administrative Staff review all available documents and information for accuracy, and determine the need for alterations, implementation, and updates. The Idyllwild Fire Board of Commissioners reviews and approves the plan.

Coordination of the LHMP is done with cooperation from the Mountain Communities Fire Safe Council, The Mountain Communities MAST partners, Riverside County Fire Department/Cal Fire, the United States Forest Service, Riverside County Sheriff's Department, CHP and Cal Trans.

#### REGIONAL (OA) PLANNING PROCESS

The Idyllwild Fire Protection District participated in several regional local hazard mitigation plan development process meetings within the Riverside County operational area. The meetings included the following:

June 6, 2022, The Idyllwild Fire Protection District participated in the Local Hazard Mitigation Plan assessment meeting held during the Mountain Area Safety Task force (MAST) meeting.

September 8, 2022, The Idyllwild Fire Protection District participated in the Local Hazard Mitigation Plan goals development meeting held during the Mountain Area Safety Task force (MAST) meeting.

December 8, 2022, The Idyllwild Fire Protection District participated in the Local Hazard Mitigation Plan, plan development meeting held during the Mountain Area Safety Task force (MAST) meeting.

March 9, 2023, The Idyllwild Fire Protection District participated in the Local Hazard Mitigation Plan, plan development meeting held during the Mountain Area Safety Task force (MAST) meeting.

June 8, 2023, The Idyllwild Fire Protection District participated in the Local Hazard Mitigation Plan, plan development review meeting held during the Mountain Area Safety Task force (MAST) meeting.

September 8, 2023, The Idyllwild Fire Protection District participated in the Local Hazard Mitigation Plan review held during the Mountain Area Safety Task force (MAST) meeting.

December 14, 2023, The Idyllwild Fire Protection District participated in the Local Hazard Mitigation Plan review held during the Mountain Area Safety Task force (MAST) meeting.

#### 2.3 DATES AVAILABLE FOR PUBLIC COMMENT

The LHMP planning process for Idyllwild Fire Protection District is ongoing and public comment is sought out to include public areas of concern.

An opportunity for public comments on DRAFT mitigation strategies is provided to the public at our regular board meetings at the Idyllwild Fire Station which take place every other month Beginning with a January meeting on the fourth Tuesday at 1500 hrs.

#### 2.4 PLANS ADOPTED BY RESOLUTION

The plan will be adopted by resolution by the Idyllwild Board of Fire Commissioners upon FEMA review and approval.

#### SECTION 3.0 - MITIGATION AND HAZARD UPDATES

#### 3.1 MITIGATION UPDATES

The remaining projects listed in previous plans for the Idyllwild Fire Protection District were not all completed. As monies required for a seismic survey of the Idyllwild fire station did not become available. This remains a viable project and should be done so that the operability and survivability of the building could be predicted to survive a 6.0 or greater earthquake. The fire department is a gathering place for local emergencies, local citizens and civic groups which make use of our conference room. The conference room is also an identified ICP location for local incidents and search and rescue operations. The main building also contains an ALS EMS treatment room.

#### 3.2 JURISDICTION HAZARDS

There are no significant changes or additional hazards which have been identified since approval of the current plan. The priorities remain the same from prior plan which is earthquake, fire and flooding. Our jurisdiction has had State and Federally declared incidents within the jurisdiction.

Unique jurisdiction incident timeline:

- 1980: Flooded Hwy 74 near Cranston which isolated Idyllwild from western access.
- 1996: Bee Canyon Fire, Idyllwild and Pine Cove Communities evacuated. Power lost.
- 2002: Western Pine Bark Beetle Infestation./GSOB Infestation.
- 2003: Southern California Wildfires
- 2005: Wind and Storm Damage, blow down of trees causing home damage and road closures.
- 2010: Extreme Weather Damage.
- 2013: Mountain Fire Incident. Idyllwild and Pine Cove Communities evacuated. Power lost.
- 2018: Cranston Fire Incident. Idyllwild and Pine Cove Communities evacuated. Power lost.
- 2019: Atmospheric River Flooding. Severe Hwy damage and commerce interruption.
- 2023: Atmospheric River Large Snowfall accumulations and flooding.

## SECTION 4.0 - HAZARD IDENTIFICATION AND RISK ASSESSMENT

#### 4.1 HAZARD REVIEW AND SUMMARY

The hazards included are much the same as throughout much of Riverside County, including earthquake, severe weather (isolation caused by downstream flooding) and wildland fires.

The Idyllwild Fire Protection District has experienced and responded to a number of various disasters over the last 8 decades, including downstream flooding and related isolation, wildfire evacuation(s); severe storm damage, western pine bark beetle infestation, and (GSOB) Golden Spotted Oak Borer infestation which creates extreme fire threat potential.

#### 4.1.4 Education / Outreach:

- Local citizen groups, nonprofit groups focused on environmental protection, emergency preparedness and functional needs of the population.
  - YES: Mountain Safe Fire Council. Idyllwild CERT (community emergency response team)
- Ongoing public information/education:
  - o YES: Annual Fire Prevention Month.

#### 4.2 **ESTIMATING POTENTIAL LOSS**

Statistically, the most vulnerable structures within the District are located along the south and west shoulders of the community. The reason for this vulnerability is due to the exposure to unimproved lands continuous fuel beds and steep topographic runs which align unfavorably up slope to the community from the larger and more populated areas of Hemet and the Soboba Indian Reservation.

Along the western edge of the community, it is predicted that not all homes would be destroyed by any one wildfire incident but an educated and predicted estimate shows that 80-100 structures are likely to be damaged or destroyed in a single wildfire event with a value loss of \$30 - \$35 million.

(During the 2018 "Cranston" fire 3 homes and several outbuildings were destroyed, an evacuation of the citizens throughout the IFPD Jurisdiction was ordered during this event with no significant injuries nor loss of Firefighter or Civilian life).

#### 4.5 IDENTIFICATION OF TOP 5 RISKS AND VULNERABILITIES

#### Items 1, 2, and 3 are "High Priority Hazards"

#### 1. Wildland Fire - Severity -4, Probability -4, Ranking -1

Wildfire is an uncontrolled fire in an area of combustible vegetation that occurs in the countryside or wilderness areas. Our most prominent threat is along the South and Western edge (shoulder) of the community where homes would be destroyed.

Vulnerability: The community of Idyllwild is particularly vulnerable to wildfire threat as
the community is surrounded by unimproved open space which contains steep/rugged
terrain and fuel beds which run continuously into the improved areas of the community.

#### 2. Earthquake - Severity - 4, Probability -3 Ranking - 2

An earthquake is a sudden, rapid shaking of the Earth caused by the breaking and shifting of rock beneath the Earth's surface. IFPD Jurisdiction is located in a Seismic Hazard Zone. The nearest active earthquake faults are located north of the community (San Andreas) and southwest of the community (Clark section of the San Jacinto fault). The Jurisdiction has experienced several noticeable ground movement incidents, such as from the Landers earthquake and the Loma Priata earthquake, but no local large-scale damage has been sustained. Masonry construction is not common in Idyllwild, but the Idyllwild Fire Station (Sta-621) is one of the few that are masonry.

 Vulnerability: The community of Idyllwild is particularly vulnerable to the threat of earthquake as the community is entirely reliant upon a single highway system for ingress and egress (HWY 243), and the community resides between two (2) of the most active southern California fault systems.

#### 3. Transportation: - Severity - 3 Probability - 2 Ranking - 3

Highway and Roadway systems are critical to the overall safety of all residents, employees and visitors of the community of Idyllwild. Extreme weather events, Fire, Wind, Rain and Snow have a severe impact on the local Highway and roadway systems. Loss of these critical Highway and roadway systems threatens life safety for all persons within the Idyllwild Fire Protection District Jurisdiction.

 Vulnerability: The community of Idyllwild is particularly vulnerable to the single highway system which provides ingress and egress (HWY 243), to the Idyllwild community. Past flooding event have caused major damage to the ingress and egress of the community. Items 4 and 5 are "lesser priority hazards" however they do create significant cause for concern and potential for adverse conditions.

Although the following risk factors do not pose as significant a threat as do items one through 3 (1-3) items four and five (4/5) could potentially have adverse effects:

#### 4. Drought - Severity -3, Probability - 3, Ranking - 4

The drought itself was weathered well by the jurisdiction through staged water conservation imposed by both Fern Valley and Idyllwild Water Districts. However, the Western Bark Beetle infestation that came with the drought stressed conifer forest caused a state declared emergency that was only recently cancelled by Governor Jerry Brown. Tens of thousands of trees were cut to mitigate fire and falling hazards and countless more have been damaged due to decades long drought conditions.

- Vulnerability: The community of Idyllwild is particularly vulnerable to wildfire. This wildfire threat is increased as our community is surrounded by unimproved open spaces which contain these dead, dying and drought stressed trees.

#### 5. Weather: Severity - 2 Probability - 3 Ranking - 5

Extreme Heat is not an issue. Extreme cold is an issue, and the Jurisdiction is part of a Warming Center plan hosted at the American Legion, Town Hall and as an overflow outlet the IFPD conference room. In both 2005 and 2016 there were County declared emergency for severe wind damage in Idyllwild and other parts of the Mountain Plateau and greater Riverside County. Throughout the Idyllwild Community trees fell through roofs severely damaged homes and caused major and minor damage. In 2022 record snowfall created access issues and also damaged several private residences and a few local commercial business properties.

 Vulnerability: The community of Idyllwild is particularly vulnerable to severe weather conditions. Although wildfire presents the greatest threat to the community, severe weather (Freezing temperatures and record snowfall) puts Idyllwild citizens and visitors at risk when critical access roads are damaged or closed and freezing temperatures force residents to shelter in place.

#### Repetitive Loss Properties:

The community of Idyllwild does not have properties which fall into this category. Idyllwild has no Historical data which indicates that it has or has had Properties with Repetitive Loss, nor do we anticipate properties having repetitive loss in the future.

#### National Flood Properties:

The Community of Idyllwild is geographically situated in such a location that we do NOT have any properties within our Jurisdictional boundaries (service area) which fall into the National Flood Mapping system. Idyllwild is situated on the topography wherein the main waterways flow unobstructed and the structurally improved areas of the community are not situated in such a way that flood has or is anticipated to be a threat in the future.

Opportunities for Improvement and Enhancement Based on the capability assessment:

Based on the capability assessment, the district has existing regulatory, administrative/technical, fiscal mechanisms in place that help to mitigate hazards. In addition to these existing capabilities, there are opportunities for the district to expand or improve on these policies and programs to further protect the community. These opportunities are organized below by regulatory, administrative/technical, fiscal, and outreach opportunities.

- 6.1.1 Regulatory Mitigation. The district updates our response plans on an annual basis. Response operations maintain and exceed industry standards to comply with state and federal regulations. Future opportunities for regulatory enhancement should focus on Development of necessary policies and ordinances which will enhance public safety and preparedness throughout the community. These policies require thorough research, education and analysis. Additional staffing of qualified personnel would expand our regulatory capabilities and allow for development of critical preventative policy and ordnances.
- 6.2.1 <u>Administrative and Technical Mitigation</u>. Future enhancements may include providing all hazard training for staff and hazard mitigation grant funding. Our staff is aware of the benefits of participating in training and webinars. Other opportunities may be related to coordinating and educating key stakeholders. Stakeholders may also be interested in aligning efforts related to hazard mitigation and also supporting and or putting together hazard mitigation trainings.
- 6.3.1 <u>Fiscal Mitigation</u>. The district should consistently apply for hazard mitigation grants to fund implementation costs associated with key CIP projects, and other related projects in the district's mitigation strategy. The district could also look to expand its fiscal capabilities by raising taxes or issuing bonds. These fiscal capabilities may be supported by district staff or augmented with consultant or part time staff positions.
- 6.4.1 Education, Outreach and Partnerships. The district can expand our outreach capabilities. Specific enhancements may include continued and ongoing public involvement through social media posts and advertisements focused on project successes related to the Mitigation Strategy as well as focused outreach to under-represented and special-interest groups. The district can also develop outreach kits for the public and partnering organizations which will in turn expand on the information we provide on current platforms such as social media and our web page. The district conducts public outreach campaigns to encourage residents to adopt emergency preparedness actions and become educated on local, state and federal ordnances.

#### **SECTION 7.0 - MITIGATION STRATEGIES**

The Special Districts coordinated with Riverside County Fire Department, multiple cities, and agencies throughout Riverside County in the creation/update of our LHMP Annex. The cooperation and discussions both in regional meetings, community outreach and internal meetings allowed for both "big picture" and "local jurisdiction" views of mitigation needs and possibilities.

#### 7.1 MITIGATION OUTREACH AND PARTNERSHIPS

The Idyllwild Fire Protection District is party to an automatic aid agreement for fire and emergency medical services with the Riverside County Fire Department. We also have automatic aid agreements with the Hemet Fire Department, Calimesa Fire Department, Canyon Lake Fire Department and a local cooperative and partnership agreement(s) with the U.S Forest Service / San Bernardino National Forest.

#### 7.2 FUNDING OPPORTUNITIES

The district has many of the same funding opportunities as Riverside County Operational Area.

GOALS AND OBJECTIVES

Goal #1: Provide Protection for People's Lives from All Hazards

Objective 1.1: Replace critical infrastructures with shake shingle roofing and encourage homeowners to do the same. Ongoing

Objective 1.2: Provide timely notification and directions to the public of imminent and potential hazards. Ongoing

Goal #2: Educate the community about hazards and associated vulnerabilities that threaten our communities. Ongoing

Objective 2.1: Educate residents about creating defensible spaces for those that live in the Wildland –Urban Interface Zone. Ongoing

Objective 2.2: Provide Burn Institute Homeowner Guide developed to help residents build defensible spaces, defensible homes, home hardening and evacuation plans. Ongoing

Objective 2.3: Encourage residents to install home fire sprinklers. (Cal Fire Code)

Goal #3: Coordinate with neighboring communities and jurisdictions to share resources.

Objective3.1: Develop Memorandum of Understandings (MOU) to share resources with special districts for mitigation and communications. Ongoing

### 7.3 2023 – 2027 MITIGATION PRIORITIES

The Board of Commissioners and Fire Chief of Idyllwild Fire Protection District identified and prioritized the following mitigation actions based on the risk assessment. Background information and information on how each action will be implemented and administered.

### 1. Enhance Fire Abatement Inspections/Fuels Reductions

Issue/Background: Fire abatement inspections are of paramount importance in containing wildfire within the community. It is difficult for the department to fund the program and bring on enough qualified inspectors to handle the 3,751 inspections and multiple (three 3) reinspections to obtain 100% compliance.

Other Alternatives: None

Responsible Office: Fire Marshall

Priority (High, Medium, Low): High

Cost Estimate: \$ 28,500 labor annually

\$ 5,500 for tablets.

Potential Funding: FEMA Pre-Disaster Mitigation grants / County Fire Hazard Mitigation Grants/ Other.

Benefits (Avoided Losses): Elimination of fire prone properties and overstocked sections of forested lands that support crown fire development. Fire behavior would be reduced, and structure losses minimized.

Schedule: Every Spring generally begins mid-April each year

### 2. Bear Trap Canyon And Other Fuel reduction projects:

A private public partnership with the owners of the "Buckhorn" and "Emerson" camps has allowed the IFPD to begin a decades old planning project to lessen the threat of fire to the community of Idyllwild. The Project is west of the downtown area and east of the "Strawberry" Fuel Break. This project completes a series of fuel reduction projects (Strawberry/Westridge/Southridge) which combine to reduce the probability of wildfire entering the populated areas of Idyllwild.

In addition, the current fuel reduction projects require ongoing maintenance and improvement. A significant effort by the cooperative emergency response partners is required to complete and maintain these critical projects.

Project Area: 5200' X 300' 1,560,000 s.f. (Approx) 35 acres

A combination of line construction and RX Fire will be utilized to attain the desired goal.

Responsible Office: IFPD Fuels Resource Management

Priority: High

Cost estimate: \$ 80,000.00

Potential Funding: (Agency and Grant Funding through the wildfire severity)

Potential Completion: June 2024

### 3. Hardening of Homes

Issue/Background: "Hardening" of Homes. Educate the public of the need to replace flammable siding and original attic and basement vents with fire resistant siding and ember proof vents. Provide grant money through Mountain Communities Fire Safe Council to offset costs to homeowners.

Other Alternatives: No Action

Responsible Office: Partnership between IFPD and Mountain Communities Fire Safe

Council

Priority: High

Cost Estimate: \$1,500,000

Potential Funding: FEMA Pre-Disaster Mitigation grants or County Fire Hazard Mitigation

Grant(s) / Other

Benefits (Avoided Losses): Prevention of home-to-home transfer of fire through ember

showers. Potentially millions of dollars in preventable losses.

Schedule: Ongoing Project will likely extend past this review period.

#### 4. P-wave Detection System

Issue/Background: The benefit of fire station automatic bay doors opening 30 seconds prior to the actual shaking of an earthquake can be the difference in the ability to respond or not. Since there is only one fire station in Idyllwild, it is imperative that the emergency equipment not be trapped inside the station.

Other Alternatives: No Action, currently the availability is dependent on the earthquake!

Responsible Office: IFPD

Priority: High

Cost Estimate: \$40,000

Potential Funding: FEMA Pre-Disaster Mitigation grants or Cal OES Grant / DHS Grants,

other.

Benefits (Avoided Losses): Much higher probability of IFPD equipment being able to respond immediately after an earthquake rather than having to cut doors open, delaying the response.

Schedule: After Funding is secured approximately 1 year.

#### 5. CERT training - Sponsored by IFPD

Issue/Background: The benefit of additional assistance during critical incidents is necessary to support successful outcomes. IFPD began providing CERT (Citizen Emergency Response Team) Training and Organization in 2005. Idyllwild's unique geographical position on the landscape opens the opportunity for large scale emergency incidents to overwhelm the daily emergency response partners and cut the community and mountain plateau off from the assistance of outside resources. With one main highway route in and out of Idyllwild, road damage, large fires and other natural disasters can easily cut off main ingress and egress routes. Other Alternatives: Additional Daily Staffing — Cost Prohibitive

Responsible Office: IFPD

Priority: High

Cost Estimate: \$20,000 Annually

Potential Funding: FEMA Department of Homeland Security

Benefits: Additional trained community members assisting with various jobs and triage.

Schedule: Ongoing (Annual initial and ongoing refresher courses).

Mountain Area Safety Taskforce – Interagency

### 7.4 Expansion of and Improvement on Mitigation Capabilities:

There are numerous methods and multiple processes that may be used to improve upon and expand current capabilities. The IFPD has identified the following items which would support and improve on Mitigation Capabilities.

- Personnel: Hiring of additional staff would strengthen our overall capabilities and increase depth allowing the IFPD to fully implement the mitigation of identified threats and challenges. Unfortunately, as with all other jurisdictions, reaching this additional staffing goal is difficult due to the overall cost to implement with the cost of payroll, benefits, insurance and training being greater than that of which the District can bear at this time.
- Governance: Continue to ensure that necessary regulations are put in place relating to building codes, ordinances, and state and federal requirements.
- Administrative: Our administrative capabilities can be improved by developing a mitigation actions implementation plan that is reviewed and updated on a recurring basis. This process would be used to update the LHMP over the coming years providing updates to the status of projects and ongoing actions.
- Fiscal: Identify additional funding opportunities that can be expanded upon for mitigation. In previous years hazard mitigation grants have not been utilized to complete any projects that have been identified by the hazard mitigation planning team.
   Outreach: Expand current capability through an increase in the number of events participated in, presentations conducted to the community through integration with HOA's and civic organizations. Promote preparedness through increased use of social media and the creation of an emergency management section to the City application.

# SECTION 8.0 – 2023 – 2027 PLAN IMPLEMENTATION AND MAINTENANCE PROCESS

Idyllwild Fire Protection District will monitor and evaluate our LHMP on a yearly basis. Over the next 5 years, we will review the LHMP and assess, among other things,

- The goals and objectives address current and expected conditions.
- The nature, magnitude, and/or type of risks have changed.
- The current resources are appropriate for implementing the plan.
- There are implementation problems, such as technical, political, legal, or coordination issues with other agencies.
- The outcomes occurred as expected (a demonstration of progress).
- The agencies and other partners participated as originally proposed.
- Changes have occurred during the evaluation, we will update the LHMP Revision Page, and notify CalOES.
- Idyllwild Fire Protection District will be in charge of the monitoring, evaluation and updating of our LHMP.

# SECTION 9.0 – 2023 – 2027 INCORPORATION INTO EXISTING PLANNING MECHANISMS

The Idyllwild Fire Protection District will incorporate the 2023 Local Hazard Mitigation Plan into our Fire Abatement Ordinance.

The enactment of this ordinance is pursuant to the authority of the California Health and Safety Code Sections 13861(h), 13879, Division 12, Part 5, Sections 14875, et seq., and Division 12, Part 6, Section 14930.

Other planning mechanisms to incorporate the LHMP plan is the following:

- Idyllwild Fire Protection District Emergency Operation Plan
- Capital Improvement Plan
- Strategic Plan
- Water System Master Plan

The Idyllwild Fire Protection District will integrate mitigation goals, information, and actions from its 2023 LHMP into the Districts Emergency Operations Plan upon the next update. The existing LHMP is already implemented into the previous planning mechanisms and once approved, the 2024 LHMP Update will also be implemented into the same mechanisms.

## SECTION 10.0 - CONTINUED PUBLIC INVOLVEMENT

After we go through the Scheduled Plan Maintenance Process, we will notify the public of any changes/no change in the LHMP Plan at the Commissioners' Meeting and on the district's website.
